## Maine Youth to Deliver Climate Change Petition to Protect Their Futures

**What:** On Wednesday, a coalition of voters and some of Maine's youngest citizens will file a climate change petition for rulemaking with the state's Department of Environmental Protection, demanding that Maine protect their futures.

The coalition, who call themselves the "Maine Climate Protectors", argue that the Department has statutory, public trust, and constitutional obligations to protect Maine's essential natural resources, including the atmosphere, for present and future generations. Maine has a 15-year-old law that set a goal to reduce greenhouse gas emissions "sufficient to eliminate any dangerous threat to the climate". Yet, Maine has not developed rules to satisfy this statutory duty.

In a spirited, art-filled celebration rally, a group of Maine youth of all ages will speak their minds on the importance of acting decisively to prevent the most dangerous impacts of climate change. A member of the Maine bar will address how the petition creates a path to achieve the goals set forth in the law.

From there, the youth petitioners and their supporters will head to Maine DEP's office on Canco Street in Portland to deliver the petition, which is signed by over 600 registered Maine voters from approximately 116 communities.
